## **Position Summary:**

The Human Resources Generalist is primarily responsible for overseeing Kalamazoo Loaves & Fishes' human resources function with direction from the Executive Director.

#### **Essential Functions:**

- Conducts recruitment efforts for all exempt and non-exempt personnel, including completing all pre and post hire screenings. Schedules and conducts new hire orientation for employees.
- Maintains and update job descriptions and coordinates with department directors to assess current and ongoing needs. Develops and updates annual performance reviews based on job descriptions.
- Maintains personnel, I-9, background check, and other files containing confidential or personal employee information following all local, state and federal regulations in regards to proper filing, securing, retention and disposal of such documents.
- Assists in development and implementation of personnel policies and procedures, and assists with the formatting of other department policies and procedures. Prepares and maintains employee handbook and policies and procedures manual.
- Manages employee benefits including health insurance, life insurance and 403b retirement account.
- Maintains vacation/sick time and floating holidays for employees. Assists with the payroll process
- Complies with federal, state, and local legal requirements by staying informed regarding existing and new legislation. Enforces adherence to requirements.
- Serves as lead staff member to Human Resources Committee, a committee of the KLF Board; transcribes HR Committee minutes for monthly meeting.
- Serves as member of the KLF Diversity, Inclusion, and Equity Taskforce.

- Established work history in human resources
- Data management systems and reporting experience helpful

- Expertise in use of MS Outlook, KLF's email/calendar, with the expectation that it will be utilized as one of the primary modes of communication both internally and externally
- Exceptional attention to detail
- Excellent time management skills; ability to manage workflow and prioritize workload

- Ability to work independently

## **Physical Requirements:**

- Requires prolonged sitting at a computer terminal
- Some bending, stooping, and stretching required
- Requires occasional lifting of 5 10 pounds
- Eye-hand coordination and manual dexterity sufficient to operate equipment required to complete position's essential functions
- Required to frequently talk and hear
- Required to frequently stand and walk
- Ability to manage the stress associated with frequent deadlines
- Specific vision abilities required include: close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus

#### **Work Environment:**

- Work performed primarily in a climate-controlled office setting
- Work is normally performed while seated with extended periods of time at a computer terminal
